

## Canadian barn fires continue unabated this summer

Farm animals have died in the tens of thousands in barn fires across Canada this summer. Twenty-five thousand chickens died in July in Kleefeld, Manitoba. Fifteen thousand pigs died at the Cluny Hutterite Colony in Cluny, Alberta in August. See CETFA's video with images from the Cluny fire: <http://www.youtube.com/watch?v=Gz270bj4o0Q>. *Warning: graphic images.* Twenty-four hundred pigs died in another fire on August 18 in Derwent, Alberta.

A CCFA representative met with senior officials in the Manitoba Fire Commissioner's office in Winnipeg to discuss the province's draft farm building code. Currently smoke

alarms and sprinklers are not required in barns, despite the thousands of animals confined – often in cages and crates – in many Canadian barns. Animals are not considered “occupants” so are not accorded even *minimal* fire protection.

### What you can do

Write federal **Agriculture Minister Gerry Ritz**, House of Commons, Ottawa, K1A 0A6 (*no postage required*) to ask him to make smoke alarms and sprinklers in barns a condition of funding for industry bailout funds.
